Advocacy and Program Highlights

Economic Development and Advocacy

We consult with and advocate for our members on issues affecting their business, and for economic development at the municipal, regional, provincial, and federal levels. We are an active member of the BC Chamber of Commerce, which represents the interests and concerns of Chambers and businesses across the province, as well as the Canadian Chamber of Commerce, which speaks for more than 175,000 businesses on national and international issues.

Topics for government relations and advocacy in 2023 included extending the deadline for CEBA (Canadian Emergency Business Account) loans, ending labour disruptions at West Coast Ports, supply chain challenges, local development proposals, and more.

Education

A key pillar of the Chamber's strategic plan is providing educational content and training in response to the needs of our membership. In 2023, we continued to update our online resource library to assist businesses in all areas of their operations, and curated educational opportunities and resources for members in our Chamber Chat weekly e-news.

The Chamber offered educational events, such as our International
